Dear Senator Sampson:

As you may recall, we first met many years ago when you were first running for office and I was the editor of The City Sun, which was published by the late Andy Cooper.

I'm writing today for your help in compelling the authorities to investigate the death of Sun Ming "Sunny" Sheu, whose struggle with judicial corruption and apparent assassination we covered in a series of articles in The Black Star News.

As a result of his experience with judicial corruption, Mr. Sheu sought the assistance of the Senate Judiciary Committee of which you were the Chair. Mr Sheu's complaint regarded the complicity State Supreme Court Judge Joseph Golia in a mortgage fraud scheme and conspiracy to steal his home (see attached articles).

In Mr. Sheu's written testimony to your committee, he further alleged that he was kidnapped by two NYPD Detectives from Queens County District Attorney Richard Brown's office, and warned that if he took his corruption complaints to the "authorities" he would be killed. In defiance of these threats, Mr. Sheu approached your Committee, with the faith that it would take immediate action on his behalf.

Rather, your Committee did not allow Mr. Sheu to testify at the September, 2009 hearings and instructed him to testify at future hearings, which were never held.

Mr. Sheu then went to the FBI to request witness protection and also made a video on Youtube claiming that if he were killed, it would be on the orders of Judge Joseph Golia and at the hands of the two DA detectives who had threatened him earlier. Mr. Sheu also had a meeting with your fellow Committee member, Senator Eric Adams, at which he also expressed fear for his life. Senator Adams told Mr. Sheu to write a comprehensive report on his situation and to submit it to the Committee. As you know, Mr. Sheu was killed on June 26^a, 2010, three days after exposing incriminating evidence regarding Judge Golia's financial disclosure forms.

The Medical Examiner declared the cause of death to be "blunt force trauma to the head with skull fractures" and the manner of death to be "undetermined" which by law requires an official investigation.

To this day there has been no investigation, and there is copious evidence of a coordinated effort by law enforcement to cover up the circumstances of Mr. Sheu's death. (see attached articles) The NYPD has also refused to respond to official FOIL requests regarding Mr. Sheu's death, in flagrant violation of NY State Freedom of Information Law. Nor has there been any investigation into the financial fraud by Golia.

Senator Sampson: the tragedy of Mr. Sheu's death should be of paramount importance to you and your Committee. It appears that Mr. Sheu was killed due to his attempts to provide your Committee with evidence of judicial corruption. If Mr. Sheu can be killed without investigation, every current and potential witness to your Committee is in jeopardy.

In your capacity as Senate Minority Leader and an ex officio Chair of the Senate Judiciary Committee, you are in a uniquely powerful position to demand an immediate and thorough investigation by the New York Police Department and the FBI.

We plan to publish a follow-up front-page article this coming Friday on the death of Mr. Sheu. We are requesting a statement from you on the course of action you propose to pursue regarding this matter.
